CANDIDATE FORUM - LIBERTY GROVE TOWN

The LWV DC conducted a candidate forum for the contested races for supervisor for the Liberty Grove Town Board. Candidates included: Frank Forkert, Nancy Goss, Michael Mercier. This forum was held Saturday, February 16, 2013, in the Liberty Grove Town Hall, at 10:00 AM. HIGH SCHOOL VOTER REGISTRATION

The League of Women Voters has a long history of helping voters get registered to vote. This spring LWV DC members will assist high school students, who will turn 18 on or prior to the April 2 Election Day, to complete mail-in voter registration forms. Staff members and community members who have moved since the last election but who will reside at their current address for at least 28 days by Election Day are eligible to register with the mail-in form as well. League members and friends of the League will be at each of the Door County High Schools to distribute registration forms and stamped envelopes addressed to the appropriate town or village clerk, and answer any questions people have about the registration forms and process. High school students and other adults are welcome to stop by and complete a mail-in voter registration form.

A copy of the person's current and valid WI driver's license (must have current address to be used) or other proof of current residence *must be mailed with the registration form* to the clerk's office up to 20 days prior to the election. Completed forms and copy of proof of residence can be mailed right from each high school office in their out-going mail; a copy of the ID/proof of residence can be made at the high school.

The following documents constitute proof of residence if they contain the voter's *CURRENT* and complete first and last name and *CURRENT* residential address, and are valid on the day used to register to vote.

- · A current and valid WI Driver License / ID Card
- · Any other official identification card or license issued by a Wisconsin governmental body or unit
- · An employee ID card with a photograph, but not a business card
- A real property tax bill or receipt for the current year or the year preceding the date of the election
- · A residential lease (Does not count as proof of residence if elector submits form by mail)

- · A picture ID or fee card from a university, college or technical college
- A utility bill for the period commencing not earlier than 90 days before the day registration is made
- · A bank statement
- · A paycheck

High school identification cards are NOT acceptable as proof of residence for voter registration.

The Candidate Forum is for the contested race for Southern Door School Board. This forum is scheduled for Monday, March 4th, 2013, in the High School Library at Southern Door Schools, beginning at 7:00 PM. Should there be inclement weather, listen to local radio for an announcement; a snow date has been set for Thursday, March 7th. Thanks to LWV members Victoria Cerinch, Peter Wyatt, Martha Beller, Bill Beller, Jennifer & Mark Moeller, and Eileen Bohn for volunteering to implement this important forum for the voters of Southern Door!

LIVELY ISSUES SESSION

Fourteen individuals attended this Lively issues session! A summary of our discussion follows: At the national League level - LWV of Amherst, MA requested support of a proposed study related to th3 2010 Citizens United v FEC decision. The LWV DC agreed to support this study. At the LWV WI level - Proposal for Review of LWV WI Position on Judicial Selection: The LWV DC believes the position should be reviewed and clarified. Look at the WI GAB as a model. Proposal for Review of LWV WI Positions on Natural Resources: The LWV DC ranked the order in which positions should be reviewed: 1. water, 2. land 3. pesticides 4. solid waste management 5. air. Peter Sigmann and Paula Olson volunteered to help with this review at the state level and pull in local LWV members for input as warranted.

At the local LWV level we discussed the following issues:

Voter Service:

- Getting young women registered and voting Look at a Women's Fund Grant
- Conduct sessions on getting women involved in local government Look at a Women's Fund Grant

- Collaborate with Libraries story hours and play groups, Health Department, Church Youth Groups
- Use our plan for HS registration plan at community venues.
- Use our HS registration plan at NWTC

Civility:

- Look at 'On Being' Pod Casts
- Determine a plan after the 2/4/13 meeting with the representatives from the Oshkosh Civility Project

Other Issues:

- Continue to advocate for legislation that addresses our local issues related to Karst.
- Continue advocacy for Family Care in Door County.
